



2025 Policies for Academy Students:

- Programming is conducted throughout the year.
- The program is open to riders aged 7 and above.
- Prices shown do not include HST.
- Payment can be made by cheque, online transaction or credit card.
- A thirty-day written notice is necessary to discontinue lessons.
- Payment is due on receipt of invoice to secure a spot in our calendar.
- Lesson and day camp fees are non-refundable. If SFR Equestrian cancels a lesson, a makeup lesson will be offered, or one lesson will be credited to your account for the next bill.
- Missed lessons If you provide us with 24 hours' notice for missing a weekly lesson, a makeup lesson will be arranged during the next month with an available instructor and horse.
- Lesson times are 1 hour for Group and 45 minutes for private or Semiprivate. Group lessons include up to 5 riders. If enrolled for Group lessons but only 1 or 2 people are present, the lesson time will be 45 minutes. If placed in a lesson spot alone or with one other person while registered for Group lessons, you will still be billed Group lesson rates. For Horsemanship and Beginner lessons, the time includes both mounted and unmounted instruction.
- Although billed monthly, lesson rates are per lesson. In months with 5 lesson days (e.g., if riding on Mondays, 5 Mondays), your invoice will reflect 5 lessons.
- Theory lessons may substitute for riding in the event of extreme weather.
- Riders must bring their own properly fitted ASTM-approved horseback riding helmet, riding boots, or boots with a heel.

ADDITIONAL FEES:

Assessment Lesson - \$95

Assessment lessons are for riders who have ridden before to determine where the rider fits into the program. Those with no experience will be automatically placed into horsemanship classes and do not need an assessment.

Priority Horse Fee - \$125/month (once a week lessons) \$240/month (twice a week lessons)

Students may request the use of the same horse for all their lessons. If approved, the priority horse fee will be added to the student's invoice. Please send us an email or talk to your instructor about horse selections if interested!

Vacation Fee "Hold the Spot" - \$35 per lesson, scheduled in advance

A \$35 "Hold the Spot" fee may be applied in lieu of full lesson fees. This may only be used for planned vacations in which written (email) notification is received a minimum of 10 days in advance of your missed lesson. These fees hold your spot from opening to our wait list.

Locker Fee - \$40/month

Lockers are available for rental in our Upper or Lower Barns. Subject to availability.

ASSUMPTION OF RISKS, RELEASE OF INTEREST, WAIVER OF CLAIM, AND INDEMNITY AGREEMENT BY SIGNING THIS DOCUMENT, YOU WILL WAIVE CERTAIN LEGAL RIGHTS INCLUDING THE RIGHT TO SUE. PLEASE READ CAREFULLY!

On my behalf, and on the behalf of any minor children participating in these activities, for whom I am legally responsible, I agree to the following:

ASSUMPTION OF RISKS:

- I am aware and understood that activities involving these horses involve many risks, dangers and hazards, including, but not limited to the following: 1. Horses, which are powerful and potentially dangerous animals, may change their behavior at any time and may, without warning, jump, run wildly, buck, kick, bite or step on people or things:
 - Horses may collide with other horses or objects or trip, stumble or fall even if being led, ridden, or attended to; 2
 - 3. Negligence (which means, in general terms, a failure to exercise ordinary or proper care) of other riders or my or my child's own failure to ride safely within my or my child's ability or within designated areas and trails;
 - 4. Equipment may fail;
 - 5. Weather conditions can change and can sometimes be dangerous;
 - 6. The nature of the terrain can change and has certain risks associated with it including, but not limited to, exposed natural objects, trees, streams and creeks;
 - 7. The activities can sometimes be in remote areas and injuries or illness may occur and it may be a considerable distance to doctors, hospitals, or any other type of assistance; and
- 8. Negligence on the part of A PROPERTY OWNER AND/OR THE PROVIDER OR THEIR STAFF.

I am also aware that the risks, dangers and hazards referred to above exist throughout the trail, stable, practice and other areas and many are unmarked. I understand and acknowledge that no amount of caution, experience and instruction can eliminate all of the risks involved and I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage and damages or loss resulting there from.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of the Provider providing me or my child with their horses or sleigh riding and other services and permitting my or my child's use of their equipment, and other facilities and the Property Owners providing me or my child with the use of their property (hereinafter collectively) referred to as "the Services"). I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I or my child have or may in the future have against a Property Owner or the Provider, and their directors, officers, employees, agents, representatives, and volunteers (all of whom are hereinafter collectively referred to as "THE RELEASEES") and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury or expense that I or my child may suffer, or that my or my child's next of kin may suffer as a result of my or my child's use of the services or due to any cause whatsoever, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OR CARE INCLUDING ANY DUTY OF CARE OWED UNDER THE "OCCUPIERS LIABILITY ACT" ON THE PART OF THE RELEASEES;

- 2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damages to the property of or personal injury to any third party resulting from my or my child's use of the services;
- 3. This Agreement shall be effective and binding upon my or my child's heirs, next of kin, executors, administrators, assigns and representatives in the event of my or my child's death or incapacity;
- 4. This agreement shall be governed by and interpreted in accordance with the laws of the PROVINCE OF ONTARIO; and
- 5. Any litigation involving the parties to this Agreement shall be brought within the **PROVINCE OF ONTARIO.**
